

**RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND

I agree to waive any and all claims that I may have, both now and in the future, against \_\_\_\_\_ (the “**Host**”), Tattle Inc., and any of their related, affiliated, associated, or otherwise connected corporations, partnerships, individuals and other entities, and all of their respective officers, directors, employees, representatives, contractors, agents, successors or assigns (together, the “**Releasees**”) and release the Releasees from all costs, claims, demands, actions, causes of action and liabilities whatsoever for any personal injury, death, property damage, or loss sustained by me as a result of my participation in, or in any way connected with, a tour or experience offered by the Host, due to any cause whatsoever, including without limitation, negligence on the part of the Releasees, their representatives, tour participants, or any other person. I understand that all personal property belonging to me is brought at my sole risk and is my sole responsibility.

I am aware that the tour or experience offered by the Host involves certain additional dangers and risks, above those usual dangers and risks inherent, which may include unexpected and uncontrollable weather extremes, and physical exertion for which I may not be prepared for. I accept and assume all such risks and the possibility of personal injury, death, property damage or loss resulting therefrom or by my participation in the tour or experience.

I confirm that I have provided the Host with all relevant details relating to my pre-existing medical conditions, allergies, and other information which may affect my ability to participate in the tour and experience. I agree to abide by all instructions provided by the Host and understand that my failure to do so may result in my removal from the tour or experience.

I FURTHER AGREE TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property or personal injury of any nature to any third party, resulting from my participation in the tour or experience.

This Liability Release and any rights, duties and obligations contained herein shall be governed by and interpreted solely in accordance with the laws of the province of British Columbia and the federal laws of Canada applicable therein.

This Liability Release shall be binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my death or incapacity.

In entering into this Liability Release I am not relying on any oral or written representations or statements made by the Releasees with respect to the safety of participating in the tour or experience, other than what is set out in this Liability Release.

**I CONFIRM THAT I HAVE READ AND UNDERSTOOD THIS LIABILITY RELEASE PRIOR TO SIGNING IT AND I AM AWARE THAT BY DOING SO I AM WAIVING CERTAIN LEGAL RIGHTS WHICH MAY BE AVAILABLE TO ME, MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES AGAINST THE RELEASEES.**
